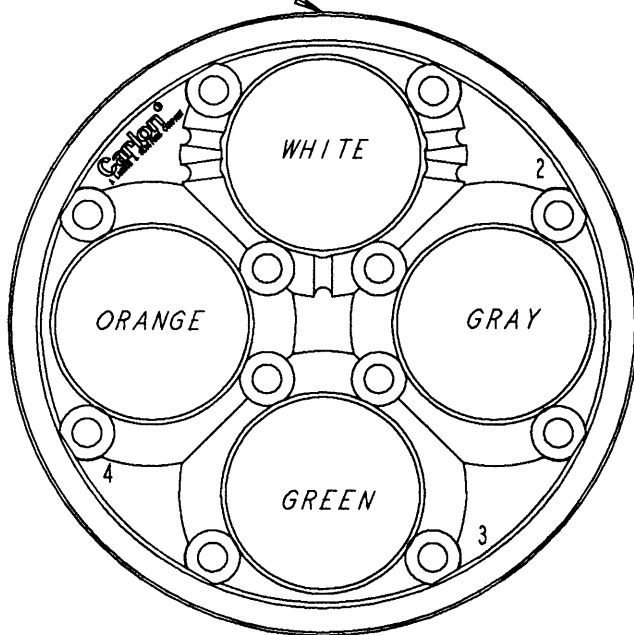

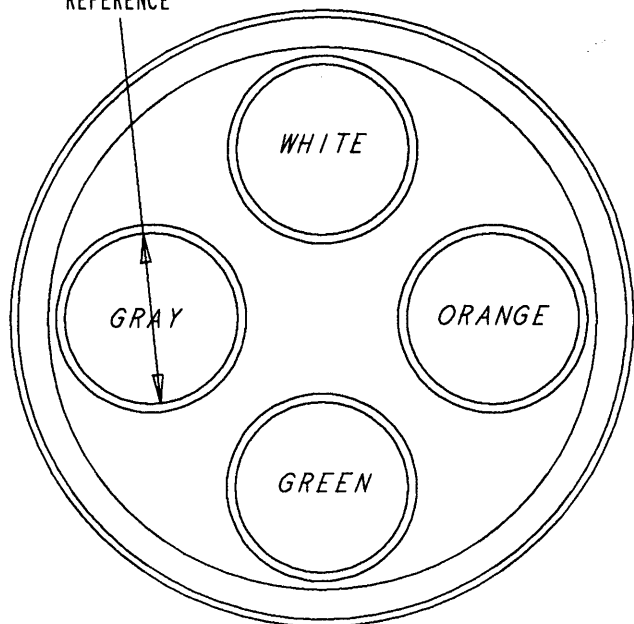

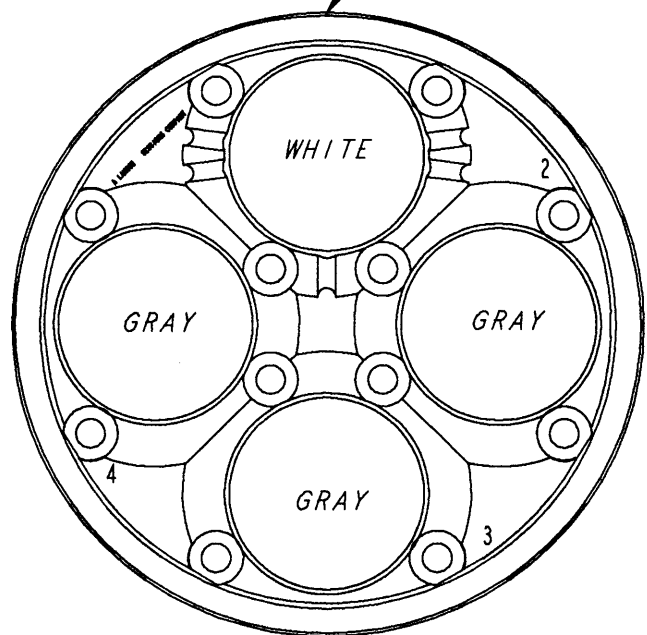


SPIGOT END VIEW

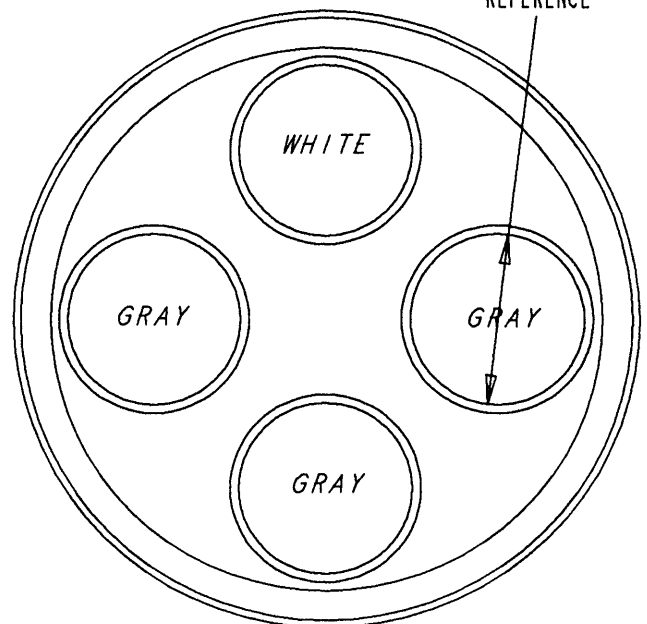

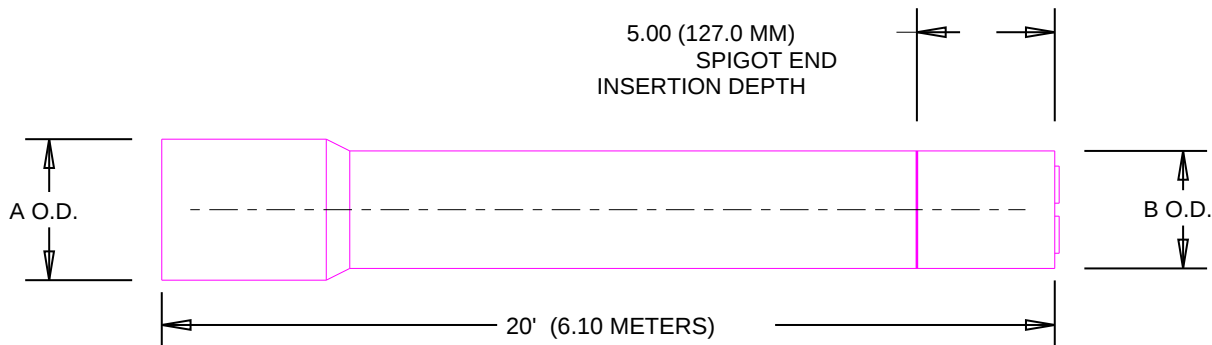
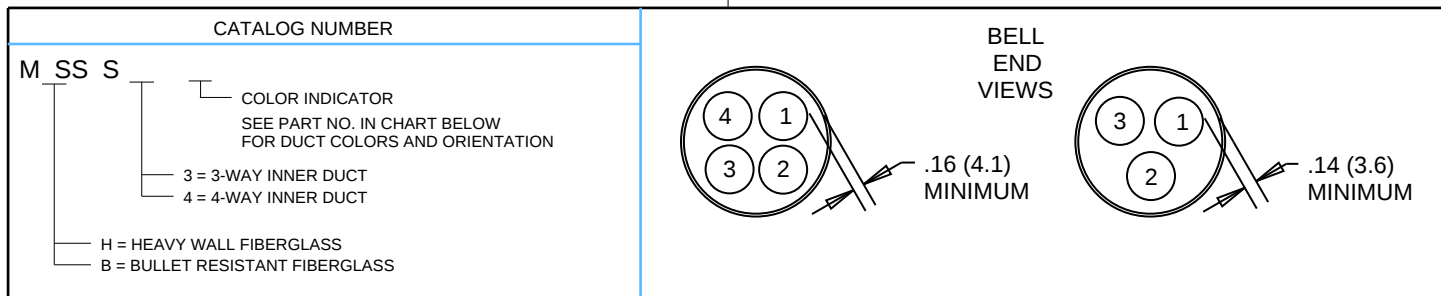
